SCHOLARSHIPS

SPECIAL SCHOLARSHIPS-2K12

For the MBA batch 2011-13 AIMIT will be offer special scholarships in the form of even **50% of TUITION FEE WAIVER** for those with XAT/KMAT/CAT ranking within 100 and for University Rank Holders. University rank holders (ranks within the first five) will have to pay only **Rs 60,000 per year excluding stay**. And those with XAT/MAT/CAT/KMAT ranking within the first 100 **will pay only Rs 1 lakh per year (excluding stay)**. The first twenty students who register with proper documentation will get this benefit.

1. Catholic students – merit cum means scholarships (**available only for those from Karnataka**)

Up to **5 scholarships** will be made available

Scholarship will be in the way of fee waiver of **tuition fees** of the first year up to 25% to 50 %. In case exceptional merit -such as in the case of rank student but of poor means we would even consider up to 50% reduction in tuition fees.

Eligibility to apply for the scholarship (Financial Assistance)

More than 70% marks in graduation (excluding languages)

Poor family financial background. This has to be supported with proper documents and recommendations.

2. General merit scholarships

Eligibility to apply for the scholarship (**Financial Assistance**)

More than 80% in graduation excluding languages. Up to 5 scholarships will be available. Scholarship will be in the form of fee waiver of tuition fees of the first year up to 25% to 50 %. Applications under this category should be submitted along with the application form.

3. Merit based FINANCIAL AID for economically disadvantaged students is available. Interest Free Loan

will be given to such students which they will have to return in installments over 3-4 years after they get the job

4. Special Financial AID is available for **five meritorious female** candidates coming from economically disadvantaged section. Financial aid up to **Rs 50,000** per year is given to such students. This Interest Free Loan is instituted by **Mrs Selma Deans, Mumbai.**
